U.S. Citizen, resident of the State of Utah for over 30 days preceding election, 18 years of age by November 21, 2023 and registered to vote in the municipality.

### **Certification of Ballot Counting Equipment**

Box Elder County will publicly conduct a logic and accuracy test and demonstration of the automatic tabulating equipment that will be used to count the ballots for the Primary Election to be held September 5, 2023.

The demonstration and test will be conducted August 17, 2023 at 9:00 a.m. in room #10 of the County Courthouse 01 South Main Street Brigham City, UT.

The test and demonstration is open to the public in accordance with Utah Code 20A-4-104 and 20A-3-201.
